1. Call to order.

He distributed a handout for the Board members from the League of Wisconsin Municipalities regarding special assessments on front footage from the case of Peterson vs City of New Berlin. He reported on the assessments on Milton Circle. He stated the assessment on a1/2 acre parcel is 1/5 of his and he has a 1/3 acre parcel. He believes it is because he is on a corner. He further stated if the Board isn't willing to re-adjust their attitude regarding front foot assessments he will be seeking legal counsel.

Paul Sponholz, 1587 Milton Circle appeared before the Board. He is asking the Board to reconsider assessing on frontage and to find another option. He also has a corner lot. He referred to legislation presented in January of 2013 that was not adopted regarding funding for local roads. He urged the Board to contact their legislatures regarding this subject and to find another option.

Mark Kainz, 1320 Snowden Drive appeared before the Board and stated that the resolution talks about Butte des Morts Meadows II and does not mention Butte des Mort Meadows I. He inquired about two properties at the end of Snowden Drive.
